# Scottish Child Payment and Best Start (2025-26)

**Scottish Child Payment** (SCP) is a £27.15 weekly payment for each child cared for in a family where an adult receives certain benefits. Families choose how to spend it.

**Best Start** is a programme of 4 other payments for families on low-incomes to help with the costs of caring for a child.



### Who can apply for SCP?

You must live in Scotland and you (or your partner if you have one) are the main person looking after a child under 16. SCP doesn't affect other benefits you receive, but to qualify you (or your partner) must receive one of these:-

- ✓ Universal Credit
- ✓ Child Tax Credit
- ✓ Working Tax Credit
- ✓ Income-based Jobseeker's Allowance (JSA)

Or, you are the only person named on any of these 3 benefits:

- ✓ Pension Credit
- ✓ Income Support
- ✓ Income-related Employment & Support Allowance

If your partner is named on one of these 3 but you are not, they should apply.

## What information is needed to apply?

- Your name, date of birth, address and National Insurance Number
- The same details above for your partner (if you have one.)
- Names and dates of birth of each child for whom you are main carergiver.
- A document showing child(ren) named on either you or your partner's claim for Child Tax Credit, Child Benefit, Universal Credit or Pension Credit.
- If you or your partner are kinship carers, proof that you or they look after the child(ren) – either a letter from the Council or copy of a legal order.
- Your bank or building society details (if you have an account.)

## **How can I apply for Scottish Child Payment?**

### What is available from Best Start?

You may be eligible for the Best Start programme if you or your partner are pregnant, or care for a young child or children, and receive one of the following:

Income Support, Income-Based Jobseeker's Allowance, Income-Related Employment and Support Allowance, Pension Credit, Child Tax Credit, Working Tax Credit, Housing Benefit or Universal Credit.

**Pregnancy and Baby Payment.** A one-off payment of £767.50 for the first child and £383.75 for additional children, during pregnancy or until the baby is 6 months. It is to help with paying for maternity or baby clothes, cots, prams, etc..

**Early Learning Payment.** A one-off payment of **£319.80** for children between 2 and 3 ½ to help pay for books, toys, trips out, etc., to support their learning.

**School Age Payment.** A one-off payment of £319.80 for children around school starting age, to help pay for school bags, school trips, after school activities, etc.

Best Start Foods gives families a monthly prepaid card to help buy nutritious food during pregnancy and while children are under 3. Weekly, it pays £5.40 during pregnancy, £10.80 for each baby 0-1 and £5.40 for each child 1-3.

### How do I apply for a Best Start Grant or Best Start Foods?

You can apply for Best Start along with Scottish Child Payment or separately.
